A Notice of Proposed Regulatory Action to amend Code of Regulations, title 23, division 6, chapter 2, sections 5001 to 5015, inclusive, and add section 5005.1 and appendices was published in the California Regulatory Notice Register on March 29, 2024. The proposed regulation amendments implement five core strategies for achieving the coequal goal of protecting, restoring, and enhancing the Delta ecosystem that form the basis of the policies, recommendations, and performance measures in the Delta Plan.
