d) Amendment of a Contract with the University of California, Davis for Acoustic Telemetry (Action Item)

The Council will consider approval of an amendment to an existing contract with the University of California, Davis to allow for the hiring of a post-doctorate from the University of Maryland.

e) Amendment of a Contract with the University of California, Davis for Chinook Salmon Re-introduction Investigations (Action Item)

The Council will consider approval of an amendment to an existing contract with the University of California, Davis to increase funding to continue research that informs best practices for Chinook Salmon re-introduction to the San Joaquin River. The amendment would increase the contract by \$140,277, for a total of \$1,890,277.

9. Delta Levees Investment Strategy Regulation Update (Action Item)

Council Staff will discuss new Delta levee information that the Council needs to evaluate and has the potential to change the prioritization of Delta levees and tracts in the Delta Levees Investment Strategy (DLIS). The Council will also consider a resolution that outlines California Environmental Quality Act (CEQA) exemptions, preparation of a notice to formally withdraw from the rulemaking process for DLIS, amend the current version of Delta Plan Chapter 7, and direct Council staff to evaluate the new information available to determine if further modifications are needed.

The amendment would increase the total amount of the contract by up to \$960,000, for a total of \$6,010,000.
