### 7. CHAIR'S REPORT (INFORMATION ITEM)

Special Assistant for Planning & Science, Amanda Bohl, provided a brief update on the two agenda items scheduled for the October 26 Delta Plan Interagency Implementation Committee (DPIIC) meeting.

At the meeting, DPIIC members will receive an update on the October 5 and 6 Science Needs Assessment Workshop. Results from the workshop will be presented at the meeting. A draft Science Needs Assessment will be released by December 2020, with the final document expected to be released in early 2021. There is also a summary of the workshop in the October Lead Scientist's Report.

The DPIIC meeting will also cover Bay-Delta climate change initiatives. Panelists will present findings from the Council's Delta Adapts initiative, the San Francisco Bay Development and Conservation's Bay Adapts effort, and address Governor Newsom's priorities around climate change. DPIIC members will discuss how to leverage and align these regional initiatives with statewide efforts.

# 11. CALIFORNIA DEPARTMENT OF WATER RESOURCES DIVISION OF MULTI-BENEFIT INITIATIVES (INFORMATION ITEM)

At the recommendation of the Chair, this item was taken out of order.

DWR's Chief of the Division of Multi-benefit Initiatives, Steve Rothert, and Branch Chief for the Delta Levees Integrity and Delta Habitat Restoration Branch, Robert Charney, provided an update on DWR's efforts regarding multi-benefit initiatives and Delta levees. Rothert provided DWR's vision for the new division and how it will work collaboratively with the Council.

Councilmembers and panelists discussed funding of the Delta Levees Maintenance Subventions Program and Delta Levees Special Flood Control Projects Program, stating that additional funding sources are needed, as current funds are anticipated to be depleted within the next 1.5 years. They also discussed addressing climate change considerations for projects and collaborating with state and local partners to align existing and upcoming levee maintenance plans.

### **Public Comment:**

Gilbert Cosio – Cosio endorses the new division and addressed two questions regarding climate change scenarios within the Delta Adapts project and projects within the Lower Sacramento River/ Delta North Regional Flood Management Group.

Osha Meserve, Local Agencies of the North Delta (provided at the end of Agenda Item 9) – Meserve stated that it is not necessary nor feasible to include an ecosystem restoration component in every levee project, and that multi-benefit not be construed to only pertain to habitat.
