RE: Comments on September 2022 Draft of the 2022 Projects Solicitation Package for Multi-benefit Projects

Dear Ms. Lobato:

Thank you for the opportunity to review and comment on the September 2022 Draft of the 2022 Projects Solicitation Package for Multi-benefit Projects (2022 PSP). The Delta Stewardship Council (Council) recognizes the objective of the Department of Water Resources (DWR) 2022 PSP to solicit applications for multi-benefit projects which promote levee improvement, habitat enhancement, emergency response, seismic resiliency, and/or export water supply reliability to further the goals of the California Water Action Plan and the Water Resilience Portfolio 2020.

The Council is an independent state agency established by the Sacramento-San Joaquin Delta Reform Act of 2009, codified in Division 35 of the California Water Code, sections 85000-85350 (Delta Reform Act). The Delta Reform Act charges the Council with furthering California's coequal goals of providing a more reliable water supply and protecting, restoring, and enhancing the Sacramento-San Joaquin River

Delta (Delta) ecosystem. (Water Code, § 85054.) The Delta Reform Act further states that the coequal goals are to be achieved in a manner that protects and enhances the unique cultural, recreational, natural resource, and agricultural values of the Delta as an evolving place. The Council is charged with furthering California's coequal goals for the Delta through the adoption and implementation of the Delta Plan. (Wat. Code, § 85300.)

Pursuant to the Delta Reform Act, the Council has adopted the Delta Plan, a comprehensive long-term management plan for the Delta and Suisun Marsh that furthers the coequal goals.

In addition to furthering the coequal goals, the Delta Reform Act requires the Delta Plan to attempt to reduce risks to people, property, and State interests in the Delta by promoting effective emergency preparedness, appropriate land uses, and strategic levee investments (Wat. Code, § 85305(a)); and to recommend priorities for State investment in levee operation, maintenance, and improvements in the Delta, (Wat. Code, § 85306).

COMMENTS ON THE 2022 PSP

Please refer to the attached document for specific comments and edits associated with the September 2022 draft PSP. We appreciate that the Delta Levee Program has incorporated the Delta Levees Investment Strategy prioritization in its scoring criteria.

As DWR proceeds with finalizing the 2022 PSP for multi-benefit projects, the Council invites DWR to engage with Council staff as needed to discuss any project changes that may develop with the finalization of the 2022 PSP.
