Council and DWR staff will present on the Delta Science Program's efforts to communicate scientific information across Delta communities. This presentation will also highlight the DELTA educational program led by DWR.

11. Consideration and Possible Adoption of Revisions to Proposed Rulemaking for Section 5001 (Definitions) and Section 5012 (Delta Levees Investment Strategy) (Delta Plan Policy RR P1) of Title 23 of the California Code of Regulations ("DLIS") (Resolution 2023-05) (Action Item)

Council staff will outline revisions to the proposed DLIS rulemaking made after the Council's adoption of the proposed rulemaking in February 2023, and provide an overview of comments received on the proposed revisions during a 15-day public comment period. The changes are proposed to respond to comments from the Office of Administrative Law (OAL) as part of the rulemaking process. The Council will consider approval of Resolution 2023-05 to adopt the revisions and resubmit the rulemaking package for the proposed DLIS regulations to the OAL for approval in accordance with the Administrative Procedure Act.
