Delta Stewardship Council Seeks Public Comment at EIR Field Hearings

(Sacramento) - The Delta Stewardship Council, the state agency charged with developing a long-term, legally enforceable management plan for the Sacramento-San Joaquin Delta, is seeking public input on its draft Program Environmental Impact Report (EIR) that reviews the 5th staff draft Delta Plan.

The Delta Plan's fundamental purpose is to meet the state-mandated coequal goals of "providing a more reliable water supply for California and protecting, restoring and enhancing the Delta ecosystem ... in a manner that protects and enhances the unique cultural, recreational, natural resource and agricultural values of the Delta as an evolving place." (CA Water Code §85054)

The draft EIR analyzes the environmental impacts of the draft Delta Plan, which includes 12 regulatory policies and 61 recommendations designed to guide state and local agencies regarding land, water, air and other systems in the Delta. The EIR also examines five alternatives, including: a no project alternative, two alternatives with increased emphasis on water supply reliability, one alternative with increased emphasis on Delta ecosystem restoration and one alternative with increased emphasis on protection and enhancement of Delta communities and culture.

Meetings will include a brief overview of the Delta Plan followed by public comments related to the draft EIR. The same project information will be presented at all meetings. The Council also welcomes written comments by 5 p.m. on February 2, 2012.
