Thresholds and Ecosystem Restoration Symposium – November 19, 2019

Among the goals of habitat restoration are the recovery of a particular set of ecological functions and services. Trying to understand and predict the trajectory and pace of recovery raises important questions for resource managers. Answers to these questions are important for restoration decision-making and the development of monitoring and assessment plans.

This one-day symposium will bring together scientists and managers to (1) inform scientists about decision-making processes and real-world challenges in ecosystem management and restoration; (2) inform managers of the latest decision support tools emerging from science on ecosystem multiple stable states; and (3) promote dialogue and collaboration among scientists and managers working on the Delta-estuary-marine ecosystem continuum. The 2019 Delta Plan Five-Year Review Report will be published in fall 2019 presenting findings from the Delta Plan Five-Year Review process and recommending priority actions for the next five years to strengthen the Delta Plan and its implementation. Adapting to Rising Tides – Eastern Contra Costa County

In partnership with the Delta Stewardship Council and Contra Costa County, BCDC's Adapting to Rising Tides initiative expanded into eastern Contra Costa County to run along the shoreline from Pittsburg to the Contra Costa-Alameda County border at Clifton Court. The ART project—the first that will take place in the Delta—will help improve local capacity to address the threats from sea level rise and current flooding. It will also serve as a pilot project for understanding and adapting to the impacts of sea-level rise in the Delta. Project completion is expected by the end of 2020. EPA Announces Development of Water Reuse Action Plan

On September 10, 2019, the US EPA announced the release of a draft National Water Reuse Action Plan for public comment. This draft Action Plan seeks to foster greater consideration of water reuse across the water sector, such as agriculture, industry, potable water, national security, environmental restoration, and more. Safe and reliable water supplies for human consumption, agriculture, business, industry, recreation, and healthy ecosystems are critical to our nation's communities and economy. Water reuse can improve the security, sustainability, and resilience of our nation's water resources, especially when considered at the watershed or basin scale, through integrated and collaborative water- resource planning.

The draft National Water Reuse Action Plan highlights key actions that support consideration and implementation of water reuse across the water sector. Development of the draft Action Plan has involved significant collaboration among federal, state, tribal, and water sector stakeholders. The draft Action Plan is intended to seek commitments across these stakeholder groups and levels of government, and drive action across the nation. The plan consists of 46 proposed actions that support consideration and implementation of water reuse applications across 10 strategic objectives.

EPA is seeking the engagement of governmental and non-governmental water sector organizations to identify priority actions and to lead and collaborate on actions identified in the draft Action Plan. EPA is soliciting public input through a 90-day comment period in the public docket (docket number EPA-HQ-OW-2019-0174). Comment on or before December 16, 2019. The Coequal Goals

The Delta Stewardship Council was created in legislation to achieve the state mandated coequal goals for the Delta. "Coequal goals' means the two goals of providing a more reliable water supply for California and protecting, restoring, and enhancing the Delta ecosystem. The coequal goals shall be achieved in a manner that protects and enhances the unique cultural, recreational, natural resource, and agricultural values of the Delta as an evolving place." (CA Water Code Section 85054)
