2. Impacts, Risks, and Management of Invasive Aquatic Vegetation in Tidal Wetland Restoration Projects (Information Item)

Staff from the Delta Stewardship Council (Council), Department of Water Resources (DWR), and Department of Parks and Recreation, Division of Boating and Waterways, will present and discuss successes, challenges, and adaptive management needs related to the control of invasive aquatic vegetation. Topics may include:

- Possible approaches for expanding and permitting adaptive management of invasive aquatic vegetation control in or near restoration sites.
- Possible approaches to better integrate invasive aquatic vegetation monitoring and control actions into the restoration planning and permitting process.

- How agencies and interested parties might support ongoing adaptive management for invasive aquatic vegetation control.

3. Recap of Delta-Suisun Tidal Wetland Restoration Symposium (Information Item)

DWR and Council staff will provide a summary of the Delta-Suisun Tidal Wetland Restoration Symposium held on November 1, 2023, hosted by DWR and the State Water Contractors.

Sacramento-San Joaquin Delta Conservancy staff will provide a summary of the November 2, 2023, Delta Restoration Forum, hosted by the Restoration Subcommittee, and discuss ideas for future community engagement.
