It emphasizes collaborations and relationships that transform shared knowledge into collective action. Staff will present the 2026 Science Plan update to the Council for potential endorsement.

9. Delta Levees Investment Strategy Annual Report (Information Item)

The Delta Levees Investment Strategy (DLIS), which became law in 2024, establishes priorities for state investments in Delta levees where risk to people, property, and state interest is greatest. The Department of Water Resources (DWR) will present its DLIS investments for fiscal year 2024-2025, and Council staff will provide an overview of key lessons learned from the seven years of collaboration with DWR.
