The Delta Stewardship Council shall conduct a hearing on the appeals of the certification of consistency as follows:

The hearing will be conducted pursuant to Water Code sections 85225, 85225.10, 85225.15, 85225.20, and 85225.25 and California Code of Regulations, title 23, section 5020 et seq. The appellants and certifying agency (respondent) will each be provided an opportunity to make an oral presentation at the hearing according to the schedule below. The presentations may only address the issues and facts raised in the appeals. (Cal. Code Regs., tit. 23, §§ 5027 subds. (e)(1), (2), 5028.) Oral presentations will be limited to 20 minutes per each appellant group and 200 minutes total for respondent. The Council will make written findings no later than 60 days following the conclusion of the hearing. (Wat. Code, § 85225.25.)

To assist the parties in their presentation, each appellant group and respondent may submit one proposed demonstrative slide presentation in accessible Portable Document Format (PDF) compatible with assistive technology totaling no more than 20 slides no later than **5:00 p.m. PST on February 9, 2026, using the 2025DeltaConveyance@deltacouncil.ca.gov email address and copying the service list. Slide presentations that are not in accessible PDF format or that exceed 20 slides will not be accepted.** Slide presentations are limited to facts and issues raised in the party's appeal and may not present substantive new arguments or information. Proposed slide presentations that do not conform to these requirements will be rejected.

Parties are expected to appear at the hearing in person.

Schedule for Council Hearing

Following a brief Council staff introduction, the parties will provide presentations pursuant to the order set forth below. The presentations will proceed consecutively until concluded, with a brief recess between presentations. In addition to questions that Council members may ask during a party's presentation, there will be time set aside on the second day of the hearing for Council member questions and discussion, at the conclusion of the party presentations. If a party will not attend the hearing or does not plan to use the full time allocated, please inform the Council at the earliest convenience via the 2025DeltaConveyance@deltacouncil.ca.gov email address.
