APPEAL PROCESS

The California Code of Regulations sets forth the administrative process for the appeal of a proposed covered action. (See Cal. Code Regs., tit. 23, § 5020 et seq.) If you have a procedural question, please submit your question via email, <u>copying all parties</u>, to: <u>2025DeltaConveyance@deltacouncil.ca.gov</u>.

Certified Record

No later than <u>five calendar days</u> from the date of this notice, the certifying agency ("respondent") must submit a certified copy of the full and complete record that was before the respondent at the time of the certification. (Cal. Code Regs., tit. 23, § 5022, subd. (e)(1).) The certified record will be made available online via the Covered Actions Portal for these appeals and the Delta Conveyance Project website. (See "Documents Available" below.)

Failure to timely submit the certified record may lead the Council to remand the matter to the respondent. (Cal. Code Regs., tit. 23, § 5022, subd. (e)(4).)

Hearing and Written Submissions

The Council will hold a hearing within 60 days of the effective date of the appeals, **unless otherwise stipulated by the parties** and the Council. (Wat. Code, § 85225.20; Cal. Code Regs., tit. 23, § 5030, subd. (a).) In advance of the hearing, appellants and respondent will each be provided an opportunity to file a written submission (Cal. Code Regs., tit. 23, § 5029; see also Cal. Code Regs., tit. 23, § 5026.) The Council will issue a *Notice of Hearing and Schedule of Written Submissions* with a hearing date and specific deadlines for the parties' written submissions once the certified record is submitted. The Council will issue a final decision on the appeals within 60 days of the hearing.
