On September 16 and 17, the Delta ISB will hold an emerging climate science symposium at the Putah Creek Lodge at UC Davis. The symposium will explore current climate projections for the Sacramento-San Joaquin Delta, related uncertainties, and how the current state of climate science is being integrated into decision-making in the Delta. The symposium will help identify information gaps that should be filled to inform management and assess how current management approaches, including climate adaptation and mitigation, align with the latest research in the field (see prospectus for details).

# Pre-symposium Event: Walk-through of Summary of Select Documents Hosted by Dr. Anna Michalak of the Delta ISB

To help inform the symposium discussion, on **September 10 at 12 PM**, Dr. Anna Michalak of the Delta ISB will hold a virtual Zoom event to provide an overview of a <u>summary of select documents</u> and the NoteBookLM tool (see <u>save-the-date flyer</u> for more details). The summary of select documents was prepared with the assistance of the artificial intelligence tool, NoteBookLM, to synthesize the current

understanding of climate stressors and hazards associated with the Delta from publicly available documents.

- 3. <u>Keynote Presentation:</u> "Climate change, the Delta, and its watersheds: What we know, what we don't, and what surprises might be out there"
  - Dr. Daniel Swain, a climate scientist at the California Institute for Water Resources, will provide an overview of changes to the stressors and hazards facing the Delta (e.g., sea level rise, precipitation) that are currently occurring or expected under future climate change and their compounding impacts.
- 4. <u>Keynote Presentation:</u> "Mists of the Future: State-of-the-art and uncertainties in converting climate projections to streamflow projections"
  - Dr. Laurel Larsen of Uppsala University will provide a review and synthesis of how climate projections are incorporated into water resource management worldwide, with an emphasis on the Delta.
- 5. Panel: Emerging Climate Research

Dr. Jayantha Obeysekera of the Delta ISB will moderate a panel discussion on emerging climate research. Each panelist will provide an overview of their cutting-edge work related to climate stressors or hazards relevant to the Delta. The following panel discussion will focus on the biggest gaps and uncertainties in the scientific understanding of Delta climate stressors and hazards. Topics that will be covered include atmospheric rivers, snowmelt,

wildfires, drought, flooding and sea level rise. Panelists are:
