The Delta ISB hosted a hybrid symposium as part of its public meeting from September 16-17, 2025, at UC Davis that brought together over 250 scientists, practitioners, and decision-makers to assess the latest climate science and its implications for the Sacramento–San Joaquin Delta. The Delta ISB will reflect on what was learned from the symposium and will discuss products coming out of the symposium.
