The Delta Science Program requested a formal review of the Delta ISB at its [public meeting on November 12, 2025](#), and released the draft 2026 Delta Science Plan on November 19, 2025. The Delta ISB will discuss its review of the draft 2026 Delta Science Plan and may take action on next steps for submitting its comments to the Delta Science Program.
